Peer Reviewed Journal:

Reviewers play a pivotal role in scholarly publishing of any journal. The process of peer review helps to validate research and establish a method by which it can be evaluated. However, adhering to certain ethical guidelines, the review of the "SEEMAANT" (सीमान्त) (AN INTERDISCIPLINARY AND MULTILINGUAL ANNUAL REFEREED JOURNAL)

is done. The guidance of the Peer Reviewers helps the Editors to come up with a good research volume.

Principles to be adhered by Peer Reviewers:

- 1. The peer reviewers should keep details of the manuscript and its review confidential both before and after the publication of the journal.
- 2. The peer reviewers should agree to review manuscripts for which they have requisite subject expertise required for proper assessment and which they can assess in a timely manner. They should further undertake to carry out their fair share of reviewing and in a timely manner.
- 3. They should try to accommodate requests from journals to review revisions or resubmissions of manuscripts they have reviewed.
- 4. It is expected that the peer reviewers should not allow their reviews to be influenced by the origins of a manuscript, by the nationality, religious or political beliefs, gender or other characteristics of the authors, or by commercial considerations. Further, they are not to use any information obtained during the peer-review process for their own or any other person's or organization's advantage, or to disadvantage or discredit others.
- 5. The peer reviewers not involve anyone else in the review of a manuscript, including junior researchers they are mentoring, without first obtaining permission from the journal.
- 6. They should be objective and constructive in their reviews, refrain from being hostile or inflammatory and from making derogatory personal comments. They also should not make unfair negative comments or include unjustified criticisms of any competitors' work that is mentioned in the manuscript.
- 7. Finally, the peer reviewers are to provide journals with personal and professional information that is accurate and a true representation of their expertise

Publication Ethics:

The primary objective behind publication of the journal is to promote and publish original research papers and thereby add substantially to the existing body of knowledge and contribute to nation building. To achieve this objective, it is imperative to have a set of ethical standard which will contribute to our holistic approach. This aspect should also serve as the guidelines for the authors. The ethical standards set forth in this regard are as follows:

- 1. The authorship should be limited to those who have made a significant contribution to the conception, design, execution, or interpretation of the reported study. This aspect ought to be followed in letter and spirit.
- 2. As regards originality and plagiarism check, the authors should ensure that they have written entirely original works, and if the authors have used the work and/or words of others that this has been appropriately cited or quoted.
- 3. Authors may be asked to provide the raw data in connection with a paper for editorial review. They should be prepared to provide public access to such data as and when required.
- 4. An author should not in general publish manuscripts describing essentially the same research in more than one journal or primary publication.
- 5. An author should provide proper acknowledgement wherever it is necessary.
- 6. If the author discerns any error in his/her paper submitted, then it is the author's obligation to promptly notify the editor and cooperate with him/her to correct the paper.
- 7. It is to be noted by the authors that the opinion expressed by them are their own and do not necessarily reflect the official views of the Publication Cell. Apart from the above, the authors are also to follow the guidelines stated below for submitting any paper:

i. The article / paper is to be sent in both soft and hard copies (typed on one-side of A4 size paper) to
